2.ALL ITEMS MUST BE HANDCRAFTED. Commercial resale items are not allowed.

This rule will be enforced. Violation of this rule is grounds for ejection from the Craft Fair without a refund of entry fee. All new exhibits must include a picture

of items to be sold along with a description of how they are made. Please help us as we endeavor to keep all items handcrafted!

3.All items must be suitable for family viewing.

4.Absolutely NO Pets or Smoking allowed on school grounds, this includes the burning of incense.

5.Booth space is 10' X 10' and located outside. Each exhibitor will need to provide his/her own shade and tables to exhibit their craft. The 10' X 10' space rule will be enforced as spaces are directly next to each other.

6.There are no volunteers to provide assistance in setting up or taking down booth spaces. Please make sure you are able to manage on your own.

7. No refunds after November 15th.

8. Exhibits must be on school grounds by 9 a.m. or we reserve the right to reassign your booth spaces[s].

9.Event will not be cancelled nor will a refund be given in the event of rain, harsh weather, or natural disaster.

Exhibitors Agree to be Responsible for:

1. Setting up and taking down their own displays.

2. Handling their own sales.

3. Providing their own change.

4. Having the booth staffed by an adult at all times.

5. Continuing to display or sell their wares until the fair is over at 3 p.m.

6. Pick up and disposal of their own trash.

7. Mission Hills will in no way be responsible for lost, stolen, or damaged merchandise.
